- DATE/TIME** Saturday, December 4, 2010, 9:00 a.m. – 4:00 p.m.
- SPACE SIZE/COSTS** Space sizes vary due to the uniqueness of the building (see Registration Form). Limited electricity will be available for a \$10.00 charge. If desired, please request electricity on your registration form.
- SET-UP** Set-up begins at 6:00 a.m. on Saturday, December 3, 2010, and must be completed no later than 8:45 a.m. The Festival begins promptly at 9:00 a.m. There will be no set up the evening before the Festival for Exhibitors.
- EXHIBITS** Exhibitors must supply their own display set-up that fits in the requested space and still leave appropriate seating and exit space within the allotted measurements. Tables must be skirted to the floor (no sheets please). Aisles are to be clear at all times. If using electricity, please bring an extension cord.
- EXHIBITOR** Work must be the Exhibitor's own original design and execution. No hobby kit work, numbered paintings, copies of commercially made products. This is a juried Festival and only quality work will be accepted. Exhibitors are responsible for their own Michigan Sales Tax. **Absolutely no Exhibitor raffles, specials/sales or early tear down of booths. Exhibitors must remain until the Festival closes.**
- EXHIBITOR'S LIABILITY** Exhibitors accept full responsibility for any loss, injury or damage to persons or property that may be sustained while on the Ann Arbor City Club's property. Ann Arbor City Club will exercise every possible care and precaution, but will assume no responsibility whatsoever for any persons or property in the exhibit areas, on the premises or in any of the parking areas.
- SPACE RESERVATION** Payment must accompany signed contract. Check, money order or cashier's check should be made payable to: **ANN ARBOR CITY CLUB. Applications are due May 1, 2010 and notification will be mailed no later than June 1, 2010.** We will continue to review applications until the Festival is full. Due to extensive advertising expenses incurred by the Ann Arbor City Club, no refunds will be made after acceptance of your application.
- FOOD** Free coffee, bagels and donuts will be furnished for Exhibitors during set-up. **Lunch and beverages will be available to order prior to the Festival date from the Club's dining room. Please note that food selection is limited. Menus will be included in your information packet to be mailed the week of November 1st.
